Mr. Adams stated he received a proxy from Landowner, Lennar Homes LLC, designating Mr. Chris Hasty Proxy Holder of 1,804 voting units. No other proxies or ballots were received. Mr. Hasty is eligible to cast up to 1,804 votes.
